Board of Directors Governance Manual

The Board reviewed and discussed the following:

- The Communication, Finance, and Transparency Policy drafts are still required to complete the manual;
- Donation Policy 2018-04 was revised to reflect that half of the budgeted donation funds are for the April 1st granting intake and a half for the October 1st intake second periods;
- The donation allocation will be decided annually and approved by the Board on April 1st in the budget;
- The Donations Committee has the authority to approve donations outside of intake dates;
- Board stipends are to be consistent for travel reimbursements and hourly wages;
- Everything is included in monthly stipend (time cards, travel, meeting package review and preparation.

Chinook Comfor Limited Partnership AGM

The AGM will be held at 9 a.m. on September 19, 2018, at the YLP building. The Annual report was reviewed, and the following was then discussed:

- The Board agreed that the report be provided to the Shareholders in advance of the meeting;
- Directors are required to attend cheque presentations;
- The Annual Report requires a picture of the Board of Directors.

General Manager's Report

General Manager Nielsen presented his report to the Board and the following was then discussed:

- The Chinook Community Forest was affected by three wildfires this season—the Verdun, Shovel Lake, and Nadina fires;
- The largest impact was from the Verdun fire. A total of 9,293 hectares of Timber Harvesting Land Base (THLB) was lost to the 3 fires. 0-48 age class: 3,000 hectares; 40-80 age class 2,613 hectares; 80-300 age class 3,476 hectares;
- 80,000 m₃ of layout and three approved cutting permits were lost to the fires; however, there is salvageable burnt wood. Salvage operations and fire risk mitigation have already begun;
- Harvesting—all harvesting activities are currently shut down and arrangements are being made for the remaining decked wood;
- LiDAR—one plot was lost in the Verdun fire; however, crews are working to complete the plot sampling project;
- Because fuel is the only thing that is controllable, work to identify and mitigate high-hazard areas in the community forest has begun with the Smithers Wildfire Branch.

Donations Report

The next intake period is in November. \$68,976.04 has been donated to the community this fiscal year
